# FASTFLASH FLEXIBLE ROOF FLASHING

This Agrément Certificate Product Sheet<sup>(1)</sup> relates to FastFlash Flexible Roof Flashing for use as waterproofing in flashing applications on flat and pitched roofs, as an alternative to lead flashing.

(1) Hereinafter referred to as 'Certificate'.

#### **Technical Specification**

### 1 Description

1.1 FastFlash Flexible Roof Flashing is a polymer based flashing material with an aluminium mesh reinforcement. The lower surface, which has a butyl self-adhesive layer, is finished with a film to protect the rolls during storage and installation.

**1.2** The rolls are available with the nominal characteristics of:

roll length (m)	5
roll widths (mm)	280, 370, 560 and 1120
roll weight (kg)	4.6, 6.1, 9.3 and 18.6
colour	black, brick red, grey, anthracite.

1.3 Ancillary items for use with the product, but outside the scope of this Certificate, are:

- Flash Seal for surface treatment of FastFlash Flexible Roof Flashing where water travels from a copper or bitumen roof onto the flashing
- FastFlash Hammer for dressing the product into shape.

### 2 Manufacture

2.1 The product is manufactured by coating both sides of an aluminium mesh reinforcement with a mixture of rubber polymer and additives. The lower surface has a butyl self-adhesive layer.

2.2 As part of the assessment and ongoing surveillance of product quality, the BBA has:

- agreed with the manufacturer the quality control procedures and product testing to be undertaken
- assessed and agreed the quality control operated over batches of incoming materials
- monitored the production process and verified that it is in accordance with the documented process
- evaluated the process for management of nonconformities
- checked that equipment has been properly tested and calibrated
- undertaken to carry out the above measures on a regular basis through a surveillance process, to verify that the specifications and quality control operated by the manufacturer are being maintained.

2.3 The product is manufactured by the Certificate holder in Denmark.

# **3** Delivery and site handling

3.1 The product is distributed in boxed rolls marked with the size and the BBA logo incorporating the number of this Certificate.

3.2 The product should be stored on a smooth, clean, dry surface, under cover and protected from sunlight.

#### Assessment and Technical Investigations

The following is a summary of the assessment and technical investigations carried out on FastFlash Flexible Roof Flashing.

Design Considerations

### 4 Use

4.1 FastFlash Flexible Roof Flashing, when designed and installed in accordance with the relevant parts of BS 5534 : 2014, BS 6229 : 2003, BS 8000-0 : 2014 and BS 8000-6 : 1990, is suitable for use in flashing applications, such as abutments, chimneys, saddles, valleys and dormers to provide a weatherproof junction.

4.2 Flat roofs are defined for the purposes of this Certificate as those having a minimum finished fall of 1:80. Pitched roofs are defined as those having falls in excess of 1:6 or 10°.

4.3 Where the product is likely to come into contact with aggressive chemicals (such as acid, alkali, oil or solvent), a test on the product should be conducted before proceeding. If any doubt arises, the Certificate holder's advice should be sought.

## **5** Practicability of installation

The product can be installed by roofing contractors experienced with this type of product.

### 6 Weathertightness



FastFlash Flexible Roof Flashing, when incorporated into a roofing system designed and installed in accordance with conventional good practice, will adequately resist the passage of moisture to the interior of the building and so contribute to the roof satisfying the requirements of the national Building Regulations.

### 7 Properties in relation to fire



7.1 Samples of FastFlash Flexible Roof Flashing, when tested in accordance with BS 476-3 : 2004, achieved a C rating for surface spread of flame.

7.2 When tested in accordance with DIN 4102-1 : 1998, the product achieved a B2 rating.

7.3 In the opinion of the BBA, the product therefore achieves an AC rating or low vulnerability as defined in the national Building Regulations.

### 8 Strength

The product will resist normal impacts associated with installation and use.

## 9 Maintenance



There are no maintenance requirements, other than a regular visual check for damage. Damaged areas can be repaired by following the Certificate holder's instructions prior to completing the roof covering.

# **10 Durability**

The product, when subjected to normal conditions and areas of use, will have a life in excess of 20 years.

Installation

### 11 General

11.1 Installation of FastFlash Flexible Roof Flashing should be strictly in accordance with the Certificate holder's instructions and the relevant recommendations of BS 5534 : 2014, BS 6229 : 2003, BS 8000-0 : 2014 and BS 8000-6 : 1990.

11.2 The product is worked the same way as lead flashing, by bossing around shapes or folding as necessary. It can be cut with a sharp knife scissors or snips. In respect of health, protective gloves should be worn during installation.

11.3 Cutting and folding, including when working with a lead dresser, can be carried out at a minimum temperature of -40°C.

11.4 Foot traffic should be avoided or a protection board should be used when installing the product as a valley lining.

11.5 If required, overlap joints of 30 mm minimum are required between the product, or if folded the minimum folding distance should be 15 mm.

### **12** Procedure

12.1 If necessary, the product can be pre-bent or shaped before mounting.

12.2 The side with the protection foil is the visible or upper face of the material.

12.3 For flashing against the wall, the top edges of the product are tucked into the masonry walls and dressed under the cavity trays. The flashing is then dressed into shape with a FastFlash Hammer whilst supporting the previous profile of the roof covering.

12.4 When using the product against chimneys, sections of the flashing should be prepared in situ before mounting, using four pieces of the flashing and folding the joints, and finishing off with a loose zinc edge.

12.5 The side pieces should be cut into the desired shape, bent along the length and folded. The flexible fold allows the flashing to be pre-bent to the desired angle.

12.6 When using the product at a chimney, it should be bent at the footing and cut at an angle on both sides. The product is mounted on the chimney using rivets. The side sections of the product should be bent and dressed into the desired shape.

12.7 When using the product in valleys, it should be used for termination at the base of the valley to dress into the main roof gutters. The valley gutter and flashing are joined with a double fold.

12.8 Joints can be completed by folding or by joining the overlaps by following the Certificate holder's instructions.

# 13 Repair

Damage to the product can be repaired easily prior to the installation of slates or tiles by patching and sealing the damaged areas. Care must be taken to ensure that the watertightness of the roof is maintained.

### 14 Tests

Tests were carried out and the results assessed to determine:

- ash content
- dimensional checks
- weight per unit area
- tensile strength and elongation at break on controls and following heat ageing and UV ageing
- resistance to tear
- resistance to water pressure
- water absorption
- water vapour transmission
- effect of heat ageing
- resistance to UV exposure and stability
- dimensional stability
- low temperature flexibility on controls and following heat ageing
- peel strength from support on controls and following heat ageing.

### **15 Investigations**

15.1 The manufacturing process was evaluated, including the methods adopted for quality control, and details were obtained of the quality and composition of the materials used.

15.2 An assessment was made of fire test data to BS 476-3 : 2004.
